

1 **NYE COUNTY RESOLUTION NO. 2024-09**

2 **A RESOLUTION ADOPTING A REVISED FEE SCHEDULE FOR NYE
3 COUNTY PLANNING DEPARTMENT**

4 WHEREAS, Nye County Code 17.04.060, authorizes the Nye County Board of County
5 Commissioners ("Board") to adopt fees for local review of applications and land use matters in
6 the areas of zoning, subdivision review and the division of land, respectively; and

7 WHEREAS, while the Board has adopted fees of local land use reviews, following a
8 periodic review of fees charged, the Nye County Planning Department finds the fees charged in
9 the current fee structure are not reasonable fees sufficient to recover incurred costs of review
10 nor do they reflect the Consumer Price Index (CPI) rates over the years; and

11 WHEREAS, the Board finds that the current fees are not reasonable fees sufficient to
12 cover the incurred costs by Nye County in processing planning-related matters; and that the
13 proposed fee changes attached herein are necessary and appropriate; and

14 ACCORDINGLY, IT IS RESOLVED, Nye County Planning Department's Fee
15 Schedule attached as Exhibit 1, and incorporated by reference, is hereby adopted, effective
16 January 1, 2025.

17 IT IS FURTHER RESOLVED, any fees or fee schedule previously adopted by the
18 Board and related to local review of applications and land use matters in the areas of zoning,
19 subdivision review and division of land respectively, are hereby superseded by this Resolution
20 No. 2024-09.

21 BE IT FURTHER RESOLVED, and hereby ordered that the Director of the Nye County
22 Planning Department shall cause this Resolution to be recorded in the office of the Nye County
23 Recorder.
